## Information Collection and Use

Place of data processing: the registered seat of the Company, or the place of work of the data processor, employee. The employees of the Company have access to the personal data processed in connection with the use of the application only to the extent necessary for the performance of their tasks, the provision of the service used by the data subject, and for answering questions and providing information.

### 3. Registration to access the application

For a better experience, while using our Service, we may require you to provide us with certain personally identifiable information. The information that we request will be retained by us and used as described in this privacy policy.

purpose of data processing: by using the system, individuals and organisations can register to manage, review, and approve annual leaves

**scope of processed data:** name of individual or organisation, registering person; user name, email address; the description and number of days of the annual leave types used in the organisation; which user applied for permission for which type of leave, whether it has been granted and by whom.

**legal basis for data processing:** consent pursuant to Article 6(1)(a) of the GDPR

**deadline of data storage:** as a general rule, the personal details of the user will be deleted within 30 days of account deletion. Exceptions to this are possible enforcements of rights or claims, statutory retention obligations, cases of any proceedings by court, prosecutor's office, investigative authority, any authority with competence to proceed in the case of infringement,

public authority, National Authority for Data Protection and Freedom of Information, or other bodies authorised by law, until these proceedings are finally concluded.

After the investigation of the data subject's request to the Company to delete the corresponding personal data, if the request is justified, the personal data will be deleted from the system immediately. Exceptions to this are data processing for the purpose of archiving out of public interest, scientific or historical research, as specified in Article 89 of the GDPR, or possible enforcements of rights or claims, cases of any proceedings by court, prosecutor's office, investigative authority, any authority with competence to proceed in the case of infringement, public authority, National Authority for Data Protection and Freedom of Information, or other bodies authorised by law, until these proceedings are finally concluded.

**method of data storage:** the personal data of the data subject is stored by the Company in electronic form

### **Rights related to data processing**

If the data subject considers that the data processing violates the provisions of the GDPR or considers the way in which the Company processes the personal data to be infringing, we recommend first to contact the Company with any complaint. The complaint will be investigated in all cases.

### **Log Data**

We want to inform you that whenever you use our Service, in a case of an error in the app we collect data and information (through third party products) on your phone called Log Data.
